

**ORDINANCE NO. 150**

AN ORDINANCE RESTRICTING PARKING OF MOTOR VEHICLES ON PUBLIC ROADS IN ADAMS TOWNSHIP, BUTLER COUNTY, PENNSYLVANIA, AND PROVIDING FOR THE ERECTION OF OFFICIAL SIGNS; AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

**BE IT ORDAINED AND ENACTED**, by the Board of Supervisors of Adams Township, Butler County, Pennsylvania and it is hereby ordained and enacted by the authority of the same:

**SECTION 93-1. PARKING PROHIBITED AT ALL TIMES**

No person shall park a vehicle at any time on the following streets:

**SECTION 93-2. VEHICLE REGULATIONS EFFECTING STOPPING, STANDING OR PARKING IN ADAMS TOWNSHIP**

(A) Except when necessary to avoid conflict with other traffic, or in compliance with law or the directions of a police officer or official traffic-control device, no person shall:

(1) Stop, stand or park a vehicle:

(a) On the roadway side of any vehicle stopped or parked at the edge or curb of a street.

(b) On a sidewalk

(c) Within an intersection

(d) On a crosswalk

(e) Between a safety zone and the adjacent curb within 30 feet of points on the curb immediately opposite the ends of a safety zone, unless a different length is indicated by official traffic-control devices.

(f) Alongside or opposite any street excavation or obstruction when stopping, standing or parking would obstruct traffic.

(g) Upon any bridge or other elevated structure upon a highway or within a highway tunnel.

(h) On any railroad tracks

(i) At any place where official signs prohibit stopping.

(2) Stand or park a vehicle:

(a) In front of a public or private driveway

(b) Within 15 feet of a fire hydrant

(c) Within 20 feet of a crosswalk at an intersection

(d) Within 30 feet upon the approach to any flashing signal, stop sign, yield sign or traffic-control signal located at the site of a roadway.

(e) On a limited access highway unless authorized by official traffic-control devices.

(f) At any place where official signs prohibit standing.

- (3) Park a vehicle:
  - (a) Within 50 feet of the nearest rail of a railroad crossing.
  - (b) At any place where official signs prohibit parking.

**(B) PARKING DISABLED VEHICLE**

(1) No person shall park a vehicle which is disabled or not capable of being legally operated upon a highway or roadway.

**(C) VEHICLES TO BE PARKED WITHIN MARKED SPACES**

(1) Wherever a space is marked off on any roadway or parking lot of an individual vehicle, every vehicle parked shall be parked wholly within the lines bounding that space.

**SECTION 93-3. REMOVING AND IMPOUNDING OF CERTAIN VEHICLES**

(A) This Section is enacted under authority of 6109(a)(22) of the Pennsylvania Vehicle Code which grants authority to the Township to remove and impound vehicles that are parked on any roadway in the Township in violation of any provision of this ordinance.

**(B) Towing and storage charges:**

(1) The Owner of any vehicle towed by the Township pursuant to this section shall be required to pay, in addition to the fine for violation, the actual costs of towing, including, without limitation, vehicle storage fees and costs, if any.

(2) No vehicle shall be removed under the authority of this ordinance if, at the time of the intended removal, the owner or the person for the time being in charge of the vehicle is present and expresses a willingness and intention to, and actually does, remove the vehicle, immediately.

**SECTION 93-4. PENALTY**

(A) The penalty for violation of the parking regulations as set forth in this ordinance shall be as follows:

(1)	Section 93-1	20.00
(2)	Section 93-2	20.00
(3)	Handicap Parking	50.00
(4)	Temporary No Parking	20.00
(5)	All other	20.00

(B) Any person who violates any provision of this ordinance shall report to the Adams Township Police Station and pay the fine within 72 hours or place in any of the special parking fine boxes installed at various locations within the Township. Failure to respond within 72 hours will result in a state citation at Additional fines and costs.

**SECTION 93-5.**

This Ordinance shall be effective five (5) days after its enactment or adoption.

**SECTION 93-6.**

This Ordinance shall be enacted as Chapter 126 of the Code of the Township of Adams. Any prior Ordinances are repealed to the extent amended, modified or changed by this Ordinance.
